## **New Business**

From Kerry Boisvert, Training Director: Summer classes in place – graduation will be first Tuesday in August (5<sup>th</sup>) Advanced obedience (5 classes) and Agility (4 classes) will be every other week (alternating weeks).

Fall classes will begin in September after Labor Day.

Tammy Snyder has made arrangements with Anne Paul for an Obedience clinic on Friday night, Saturday and Sunday, October 7, 8 & 9, 2011. Further details will be forthcoming.
